Placement Guidelines and Testing

Placement in math, reading, and writing courses at Missouri Western is determined by ACT/SAT subscores. Depending on scores, students may be required to take developmental courses before completing general education requirements in these areas. Placement exams allow students an opportunity to test out of a developmental course. There is no cost to the student for placement exams.

<u>General</u>

- Placement tests are given at specified times as listed on the websites below, as well as during registration programs.
- o ACT, SAT and Placement Exam scores can be found on Griffon GPS under "Student Info".

English Placement

- ENG 104 has pre-requisite of test scores shown on chart above <u>OR</u> a C or higher in ENG 100 or SAT Reading/Writing score of 500 or higher.
- Essays are read and scored by two separate faculty members. If those scores are in agreement, the student is placed. If the score is "split" (i.e., 3 and 4) the essay goes to a third reader for the final determination of placement. Placement is not just one faculty member's decision.
- To be eligible for ENG 108, a student must receive a C or higher in ENG 104.
- ENG 112 will count toward General Studies Honors requirements; however, a student does not have to be in the Honors Program to enroll in ENG 112.
- ENG 100 does apply toward graduation but it does not apply toward general studies requirements.
