An MWSU Senate Bill to transfer unused funds from budget line 1.2.3 Appropriations to budget line 1.2.1 Travel in the SGA budget.

WHEREAS, the Financial Oversight Committee has exceeded their original budget of \$15,000 for budget line 1.2.1 Travel; and,

WHEREAS, the Financial Oversight Committee has completed allocating funds from the 1.2.3 Appropriations budget line for FY18; and,

WHEREAS, students and RSOs can continue to ask for funding for travel for the Spring & Summer semesters; and,

WHEREAS, per Bylaw Article IV, Section 6D unused funds from budget line 1.2.3 will rollover to budget line 1.2.1 for the 2018-2019 (FY19) budget.
